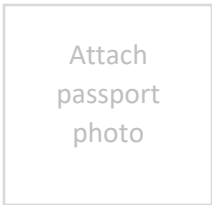

1. Share capital classification
 - a) **Class 'A'** - Ksh. 20,000/=

Member will access unlimited BOSA and FOSA services (loans and deposits)
 - b) **Class 'B'** - Ksh. 1,0000/=

Member will access all FOSA services with limited BOSA services (loans and deposits)
